

Minutes, Cemetery Board Meeting - May 27, 2007



Steve Kennemer called the North Burns cemetery association annual meeting to order at 1:30 p.m. on Sunday, May 27, 2007. J. K. Webb moved to approve the minutes as published. Terry Shinn seconded the motion, which was approved.

The financial statement, published in the May 6, 2007 cemetery association mailing, was read and discussed. Glen Shinn moved and Terry Shinn seconded the motion to accept the profit and loss statement for 5/01/2006 - 5/01/2007. The motion passed.

**Old business:** Terry Shinn reported that Cheryl Adams and he had contacted all area funeral homes regarding information on internment. They had replies regarding six internment's. Terry received the information and updated the cemetery map. The plat map is up to date.

Terry Shinn read and discussed the profit and loss statement. There was discussion regarding the sale of cemetery lots and the terms of certificates of deposits. Steve Kennemer reported a new producing well in section 26-10-9 that will bring revenue to the Association. The association remains in good financial standing.

**New business:** Terry Shinn discussed the return of spaces 3 - 4, block 2 lot 42 to the Association. The two spaces have been resold. Other lots sold during 2006 - 2007 include:

The motion passed to consider selected changes during the 2008 Association meeting.

Tricia Dickson moved and Carl Kennemer seconded a motion to adjourn. The motion passed and the meeting adjourned.
