

Minutes, Cemetery Board Meeting May 30, 2010

The top rail on the fence also needs some attention. Steve will check on this and repair and/or paint before next year's meeting.

The container with the map and cemetery information also needs to be painted. Terry Shinn will check on some way of displaying a map for cemetery visitors.
